- Brief summary of shire plans moving forward. The shire will need to extend facilities toward catering for the growing football members and interest.

- Accounting software has been updated
- Acknowledgement and thank to sponsors tis results in a healthy financial start to the 24 season
- There was a substantial growth in registrations during 23, particularly the 7-8 league
- Report explained: canteen profit significantly less due to restructure of canteen roll out
- Subscriptions cost attributed to training apps proven to be successful
- CW marquee was an excessive cost and unforeseen
- Football costs stands out since it is a separate item to last year
- Trophy cost high due to: renewal of old league cups, introduction of new competitions which require additional medals.

- Uniform cost attributed to major uniform changes & CW
